Ringing Master's News

District Ringing – January-March 2023

Another fairly positive quarter for District Ringing events.

January - Meeting: (Chartham)

A solid turnout of 22 for the afternoon ringing and it was good to see several new members amongst them. Touches of Plain Bob 6 and Grandsire 5 were rung before finishing off with course of Cambridge S6 and Stedman 5.

(Rounds+CC * 6, Plain Hunt 5 * 1, Plain Bob 5 * 1 touch, Grandsire 5 * 1 + 2 touches, Stedman 5 * 2, Plain Bob 6 * 1 + 1 touch, St Clements 6 * 1, Cambridge S6 * 2 + 1 touch)

January – S Major Practice: (Elham)

Another good turnout of 17 giving us a busy practice – which meant we stuck to half courses. With the people available we were also able to ring Superlative and Pudsey in addition to Cambridge and Yorkshire. Although there were still some method problems in places it was generally a good practice and we hope that people will start to learn the calls and all the placebell starts so we can spice things up a bit.

(Cambridge S * 3*0.5, Yorkshire S * 4*0.5, Superlative S * 1*0.5, Pudsey S * 1*0.5)

February – Plain Minor Practice: (Sturry)

We had 11 people for this practice focussing on Plain Bob, Little Bob, St Clements, and Single Oxford. We kicked off with a couple of courses of Plain Bob to get non-locals settled in then went through a series of 2-courses of St Clements for each of those who had learnt it. This was followed by 2 single-courses of Little Bob and 3 single-courses of Single Oxford before finishing with a touch of Plain Bob.

(Plain Bob 1*2-courses + 1 touch, St Clements 4*2-courses, Little Bob * 2, Single Oxford * 3)

March - Call-Change Competition: (Northbourne) - this is reported separately.

March - Basic Doubles Practice: (Waltham)

Another good showing for this practice with 12 attending (with a further 2 unable to make it on the day). Having got the bells up and rung a couple of sets of Rounds to get the feel of the bells we started off with some long sets (3-courses) of Plain Bob interspersed with a touch of Grandsire and a 3-course set of Reverse Canterbury. This was followed by a 2-course set of All Saints and further 2-course sets of Plain Bob. Unfortunately time beat and we did not manage to fit any Antelope in (sorry about that – but hopefully we will find an opportunity to ring it at one of the future District Meetings).

(Plain Bob 3*3-courses + 3*2-courses, Grandsire 1 touch, Reverse Canterbury 1*3-courses, All Saints 1*2-courses)

Another big thank you to all those who have supported this District Ringing, it is a good start to the year and something that, together, we can build on.

We have had a little feedback on possible ideas for future ringing events (see article in Jan-2023 Newsletter). Please do keep your feedback coming, either via the email address below or speak to us at meetings. Some requests we may be able to help with on a one-to-one basis at ringing meetings, but there was also some broader interest in a raising/lowering event.

District Ringing – Looking Forward (April-July 2023)

We have quite a bit coming up in the next quarter, especially with the April meeting at Faversham being an opportunity for the District to enjoy the recently refurbished and augmented ring of 10. The ringing there will include rounds and call-changes and basic 10-bell ringing such as Plain Hunt on 9 or 10. We also hope that we will have enough experienced ringers to make courses of Grandsire Caters, Stedman Caters, Erin Caters, Plain Bob Royal or Little Bob Royal practical (there may not be time to fit everything in). While we hope to make good use of all 10 bells we know this is not everyone's cup of tea, so there will be some 8-bell and 6-bell ringing as well.

May is taken up with the Striking Competition (Chislet) then in June we are at Gt Mongeham – this should be a good opportunity for those who went to the Plain Minor practice to ring Single Oxford again. Looking into the start of the following quarter the July Quarterly meeting is at Lyminge. If you have read the report on the last quarter's District ringing you will get an idea of the variety of methods we have been able to ring – but if we get the right people in the tower we can try other methods as well.

For the future District Practices we are going to ask for a tower/church donation of £1 per attendee to help them cover their costs. April is a Surprise Major practice at Boughton-under-Blean; those who have been learning Cambridge and Yorkshire may want to look at the calls. Hopefully Superlative will stay on the menu, and perhaps Lincolnshire for those looking for something beyond Cambridge & Yorkshire; maybe Bristol if we get the people.

The May practice is at St Laurence in Thanet and a chance to build on the 10-bell method ringing from Faversham – so Grandsire Caters, Stedman Caters, Erin Caters, Plain Bob Royal, and Little Bob Royal are all possibilities.

In June we are at Herne and the plan is to focus on those who want to practice calling call-changes. We are still confirming date and time for that so watch out for updates (email and District Facebook page). Looking further ahead to July and we have the next Surprise Major practice at St Stephen's, Canterbury. We are also making some adjustments to the later practices as Quex Park is not available at a convenient date in August and we have had feedback expressing interest in a Raising & Lowering in Peal practice.

In addition to all this we also need to put together our District band for the County 8-bell Competition on 17-Jun-2023. The test piece is a touch of St Clements College Bob Major – so we may be dropping that into the ringing at District Meetings/Practices if the opportunity arises. We will be asking around to see who is available to ring or help out with practices and will be aiming to draw from our pool of Surprise Major ringers.

We look forward to seeing you at the next District Meeting and don't forget the County AGM on 10-Apr-2023.

Catherine Davis 16 February 1947 — 21 December 2022

Though both keen ringers I only had the privilege of ringing with Catherine once, this being in the autumn last year at a Friday night practice at St Dunstan's in Canterbury — a few months after I came back to ringing and a few months before she died. However, we had plenty to catch up on as our working lives at St Edmund's School coincided for the best part of twenty years, Catherine being the headmaster's secretary whereas I was a housemaster and classroom teacher. She spoke enthusiastically of many interests. It was obvious to me how much she loved coming to St Dunstan's to take part in the ringing, while at the same time qualifying her excitement with a modesty about her method ringing ability.

To those who only knew Catherine in the context of bellringing it may be interesting also to read about her life outside our hobby. John Tyson, headmaster at St Edmund's through the 1980s and early 1990s, writes:

'When Francis Rawes retired as headmaster in 1978, his secretary also retired. It would not have been ideal for a brand new headmaster to have a brand new secretary — the blind leading the blind, so to speak. But Francis had a brilliant idea. Catherine had previously been involved in the school's administration before going off to work in Grand Cayman. But she was now back in England and, when sounded out, was happy with the idea of returning to St Edmund's. Being a clergy daughter herself, she was an excellent fit and very much in tune with the school's foundation and ethos. So we bought her an IBM golfball typewriter — quite an advance for the old-fashioned school St Edmund's was at the time — and she threw herself into her new role as headmaster's PA with great enthusiasm. With her pre-existing knowledge of the school and city she was a great help to me as I felt my way ahead. Coincidentally, we shared February 16th as birthday, which I took to be a good omen. She was exactly ten years younger. She was proud to have been born on Quingagesima Sunday in 1947 (hence her nickname of 'Quink').

'Catherine regarded her work in the school as a vocation and way of life rather than just a job. She was hugely interested in all the activities of the school and in its human side as well as in fulfilling her administrative and supportive roles for me. I found her to be a person of great ability with a clear mind and extremely wide enthusiasms, quite the polymath. Her skill in photography was most useful, and she frequently took pictures of school events or notable visitors. She was a keen campanologist and often joined the ringing team at St Dunstan's Church just down the hill from the school. I think too of her beagling, her cats, her 1969 Morris Minor (known as Henry), her love of riding. She loved too her house in Alma Street. Also she became a Justice of the Peace and I had to let her off school for occasional cases in court.

'Every day she seemed to have new stories of the latest doings in her varied life. Sometimes her ebullient chattering might even have slightly delayed the typing up of HM's correspondence, but never mind — everything did get done, and to a very high standard. She had a talent for publicity, for marketing and for setting up databases, so in the early days of computerization she changed her role to became the school registrar.

'I cannot possibly list all the ways in which Catherine helped, guided and protected me over the years but I shall be forever grateful to her. Mind you, she didn't suffer fools gladly and no doubt some of us were foolish at times, but her heart was definitely in the right place. Although my wife Nigella and I now live at some distance from Canterbury we shall miss Catherine very much, and our occasional communications

with her. But we have a memorial to her in our Gloucester garden. A while ago she gave to us a chunk of stone she had purchased, taken from the West Window of Canterbury Cathedral when the window was being renovated. It will serve as a permanent reminder of her friendship, her cheery smile and her talented persona.'

As a resident and member of the Northgate Association Catherine lobbied for the usual things: more trees, better parking for residents, keeping open spaces, and so on. In the same vein Catherine was an enthusiatic supporter of the campaign for Kingsmead Field to be kept as an open space — it is now a designated village green. She was there on rubbish collecting and bulb planting days, litter picker or trowel in hand.

As scorer for the Millers Arms cricket team in the 1980s Catherine travelled round various pitches in east Kent and in the process taught her neighbour how to be scorer too, so she would have some company while the team was out on the field. Among other achievements she worked as a volunteer sorting shards of pottery with the Canterbury Archaeological Trust, she learnt how to scuba dive, and she took part in ringing at churches in the places she visited while in the United States. Catherine was a popular host with students from overseas studying at Christchurch College.

Despite many challenges in her life Catherine was always upbeat in her attitude, putting heart and soul into everything she did. May she rest in peace.

Call-Change Striking Competition Results

St Augustine, Northbourne. Saturday, March 11th 2023.

After several unavoidable delays, the District Call Change striking competition took place at Northbourne on March 11th. The Judge was our Association Chairman, Neil Jones and nine teams took part, believed to be a record.

Northbourne are a pretty little six, tenor 8 $\frac{1}{2}$ cwt. Many of those attending were more than pleased to see that the notorious old ladder which formerly gave access has been replaced by an iron spiral stair. The ringers present – some 60 or so – were welcomed by the Church Warden Philip Blair, whose team had produced a splendid tea, despite members having to take it in turns to get to the food in the little church hall.

This also being a bye-meeting, Isobel Legg, Reader at St Alphege, Whitstable, conducted a pleasant afternoon service. After the Service, David Cawley introducd Neil Jones whose opening remark was "How ever does the Canterbury District manage to get so many teams for a Striking Competition?" After some general – and largely complementary and constructive remarks - Neil admitted that one team had stood out with "ringing that was almost metronomic"; the runners-up, separated only by a point, were described respectively as "very pleasant to listen to" and "fine ringing". As can be seen from the results, there was very little between some of the other teams. The results were given, as usual in reverse order:

THE BELLS OF NORTHBOURNE

The Church of St Augustine is mainly of Norman date: there have probably been Bells ringing from this tower since the early 12th century. In 1711 a new ring of Bells was ordered from and cast by Matthew Bagley, at that time the supplier of armaments to the Royal Armoury. The ring of five was in use for just under 200 years: in 1909 the Bells were taken to the foundry of Alfred Bowell of Ipswich. The two smallest were recast and the three larger were tuned. They were rehung with all new fittings in a news steel frame, unusual in that it spans the belfry diagonaly north-west to south east. The sixth Bell, the Treble was added two years later, the bicentenary year of the original ring and and to commemorate the Coronation of King George, great grandfather of King CharlesIII, whose coronation takes place this year.

WELCOME TO ST MARY OF CHARITY

The Parish Church of Faversham

It is the Spire that draws one to St Mary's. Designed to follow the pattern of Wren's St Dunstan in the East, in the City of London, it was designed by Charles Beazley to crown this, the second largest Parish Church in Kent. The present Gothic appearance of the Tower is due to the restoration work of Sir Gilbert Scott in the 1850's.

The Foundation Stone had been laid in 1794: originally there was a Central Tower at the Crossing which was demolished when the Nave was rebuilt, the work being finished in 1767. It is said that Bells hung in this Tower. The Church was given a massive ring of five – the Tenor weighed nearly 35 cwt – cast by Joanna Hill in 1441. This great Bell was twice recast, the last time in 1610, probably by Joseph Hatch, who was engaged in similar massive works at the Cathedral.

The Church possessed also another tower: the base of it remains at the west end of the north aisle. It was to this tower that the Bells migrated, having been recast into a Ring of Eight by Robert Catlin of Holborn, London. When in turn the North West Tower was demolished, the Bells were put into store until the fine new Tower was ready to receive them. Four of them are in use to-day – others have been recast as the inscriptions show, and now their long history is complete, being augmented to 10 and rehung in their 18th century frame by John Taylor & Co of Loughborough.

KCACR Canterbury District District Striking Competition Rules

(Adopted at the ADM in October, 1990, amended at the ADM in October 1999 and further amended in October 2006)

- 1. The competition shall be held annually within the District at a location and on a date to be decided by the District Committee and shall be subject to the following rules.
- 2. The Competition shall be organised by the Assistant District Secretary in consultation with the District committee.
- 3. The object of the competition is to improve the standard of striking through friendly competition between bands representing towers in the District in union with the Kent County Association of Change Ringers.
- 4. All members taking part shall be members of the Kent County Association of Change Ringers and regular Sunday service ringers at the tower they represent.
- 5. Bands shall be named on the entry form provided by the Assistant District Secretary, although not necessarily in the order of ringing in the test piece.
- 6. No ringer may ring more than once or represent more than one tower in the same competition.
- 7. A draw for the order of the bands competing shall be made by the leaders of each band before the competition, bands to be known by numbers only not by name. No two bands shall be in the ringing chamber at the same time. A steward shall be in the tower for the better observance of these rules and shall see that the bells are raised and rung beforehand.
- 8. Each band shall be allowed one continuous period of two minutes for a trial round of changes at the end of which the bells shall be set. A whole pull is to be rung on the treble to indicate to the judge(s) that the band is ready and the test piece will then commence and continue to its end without break.
- 9. Subject to any alteration arising from the application of rule 10 the test piece shall consist of either 240 changes of doubles on five or six bells or 240 changes of minor or, if the band entered is incapable of ringing changes (to a reasonable standard to be determined by the District Committee), the equivalent length of call changes, in which case there must be at least 24 different changes at regular intervals with at least five working bells.
- 10. The competition organiser may halve the length of the test piece stated in rule 9 if a) More than 8 teams have entered the competition or b) The competition is unduly delayed. In event that the test piece length is altered due to a delay after the competition has started then the bands that have rung the full length shall only be judged on the first 120 changes of their test piece and any marked rounds. Any band ringing call changes shall only be required to have 12 different changes at regular intervals with at least five working bells.

- 11. The first 10 whole pulls of rounds in the test piece shall not be marked. All faults in subsequent rounds and changes shall be penalised and the competition judged on the total number of faults recorded subject to any adjustment allowed under rule 10.
- 12. Any band failing to complete the test piece shall be disqualified.
- 13. There shall be one or two judges, preferably independent of the District, who shall know only the numbers of the bands competing. Their decision shall be final, subject to the observance of these rules, and the judge(s) shall give the results and comments at the meeting following the competition.
- 14. The Frank Knight Cup will be awarded, with a certificate, to the winning tower, who will be responsible for its safe keeping. It shall be returned in a clean condition to the Honorary District Secretary before the next competition or after a period of one year if no competition is held within that period.
- 15. The decision of the District Committee as to the interpretation and observance of these rules shall be final and binding on all parties. Such decisions shall be by a simple majority of the Committee present and voting.
