The 127th Annual Meeting of the Council will be held on SATURDAY 7th September 2024 at West Exe School, Hatherleigh Road, Exeter, Devon EX2 9JU

1. The Treasurer and one Ordinary Trustee retire. Fergus Stacey (currently Treasurer) is entitled to stand for a further two-year term. Thus, nominations are invited for the position of Treasurer and one Ordinary Trustee. In accordance with Standing Order C7.2 nominations must reach the Secretary no later than **Saturday 27th July, 2024*** and should include the names of a proposer and seconder (each being a **Representative Member**), confirmation of the nominee's agreement to be nominated; and a supporting statement of up to 200 words. Please note that whilst they must be proposed and seconded by representatives of one or more affiliated societies, nominees themselves need not be existing Council Members.

2. Nominations are also invited for election of one or two **Independent Examiners**. In accordance with Standing Order C7.2, nominations should likewise reach the Secretary no later than **27th July 2024***. Please note that in accordance with Standing Order F4.1 an Independent Examiner need not be a Council Member.

3. Notices of Motion for consideration at the meeting, with the names of a proposer and seconder (each being a **Representative Member**), together with any supporting statements (Standing Order C2.1), also must reach the Secretary by **27th July 2024***. Please note that all Representative Members, including representatives of registered small societies, are welcome to propose or second notices of motion.

4. The meeting will also receive and consider the Annual Report of the Trustees and Accounts for 2023, and the Annual Report of the Executive for 2023/24 and its Forward Plan and Budget for 2024/25.
